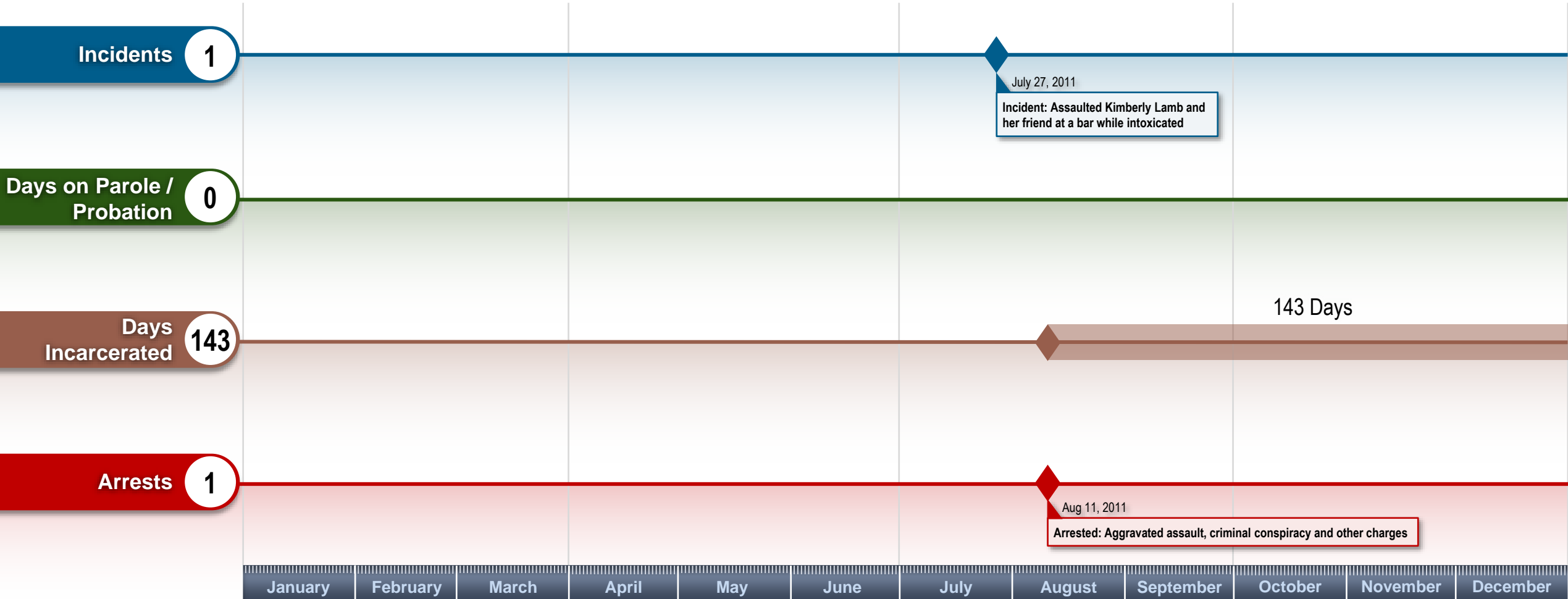


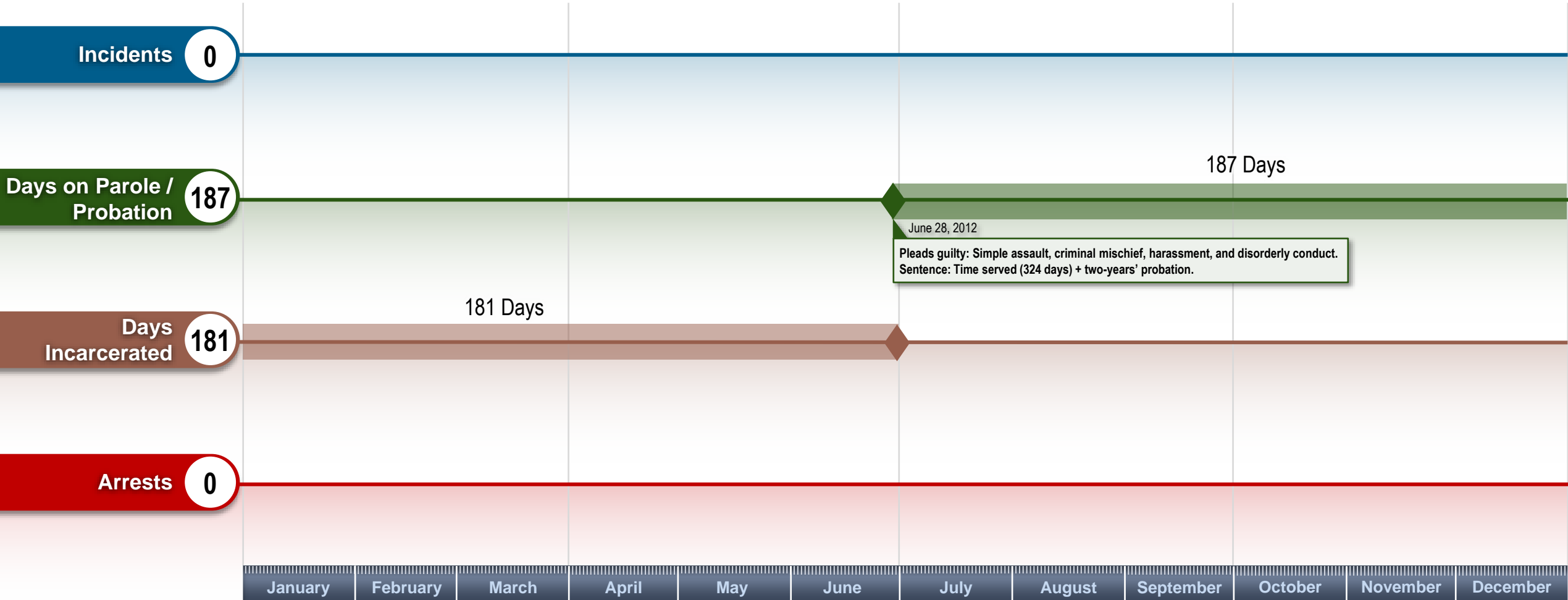

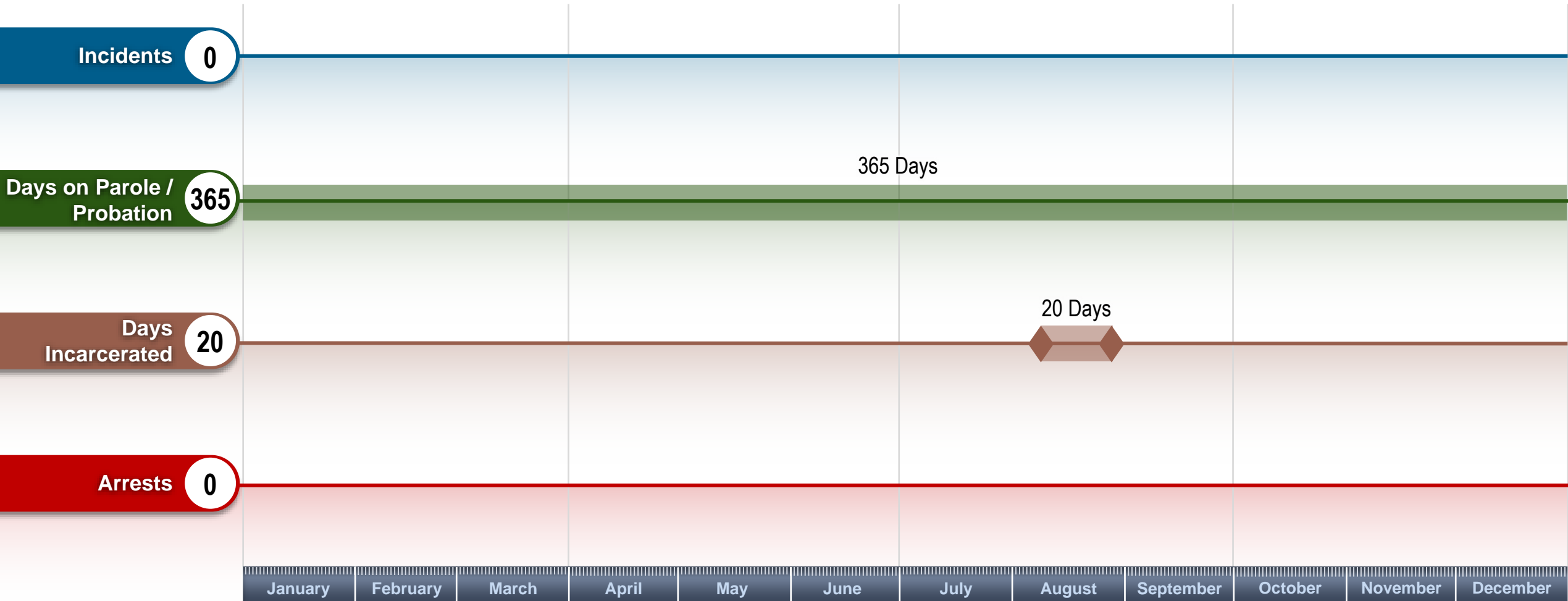


# Shakil Hairston Criminal History 2012



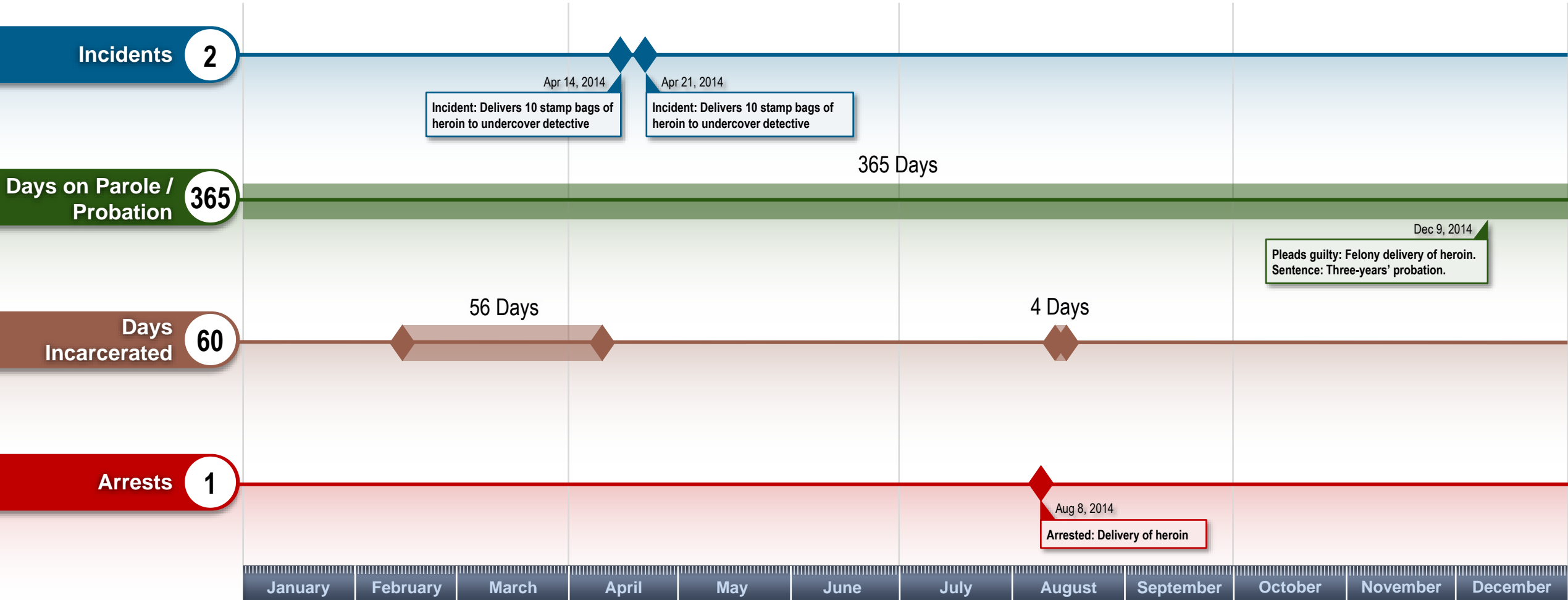


# Shakil Hairston Criminal History 2013



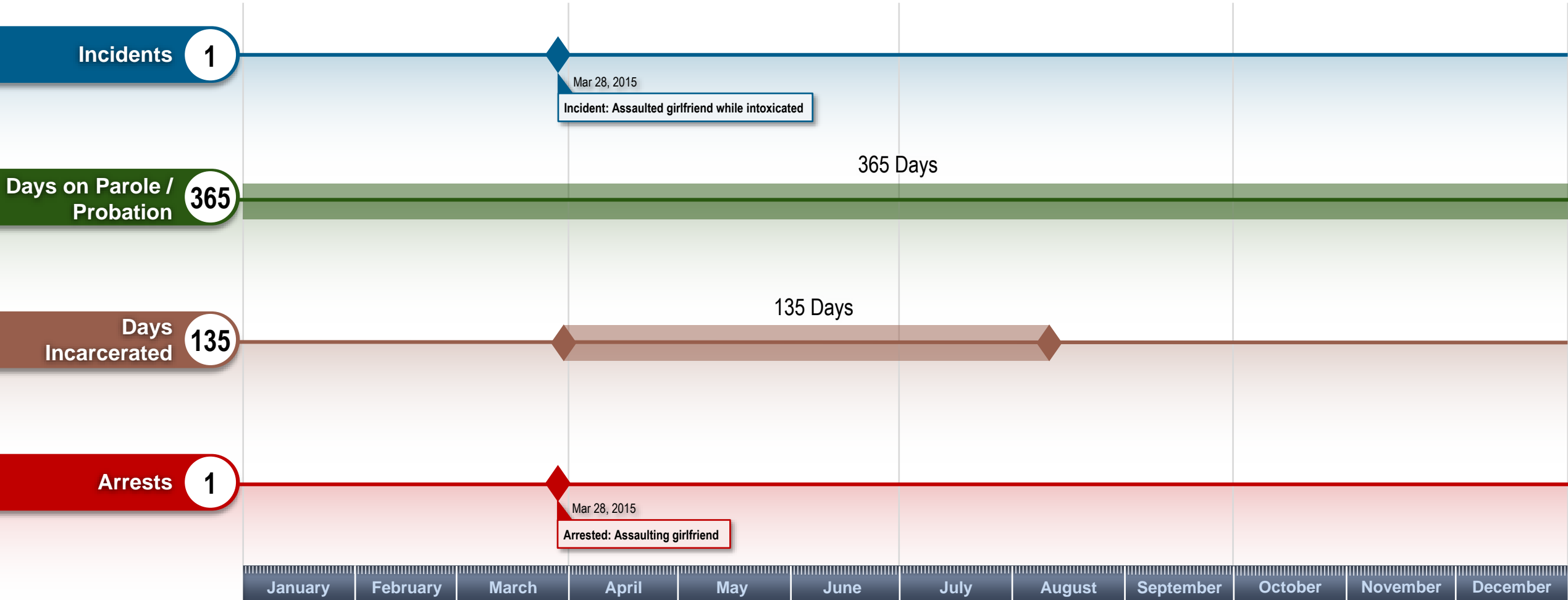


# Shakil Hairston Criminal History 2014



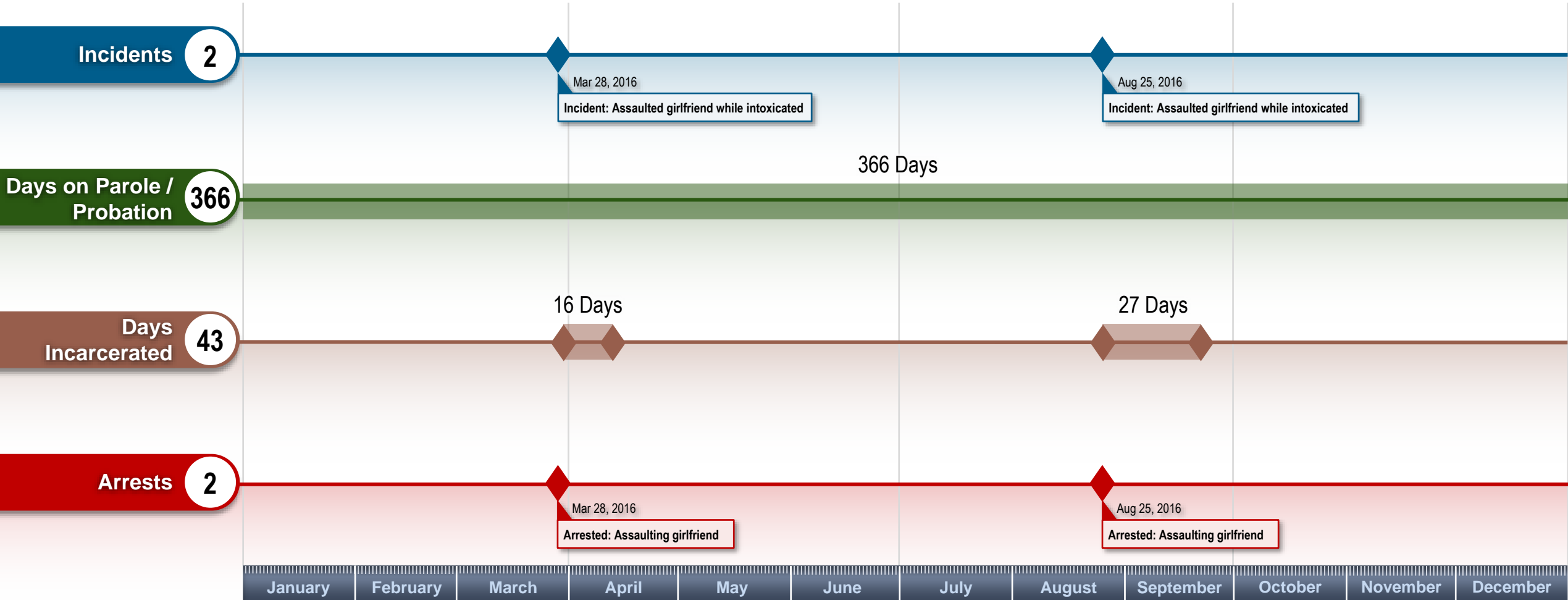

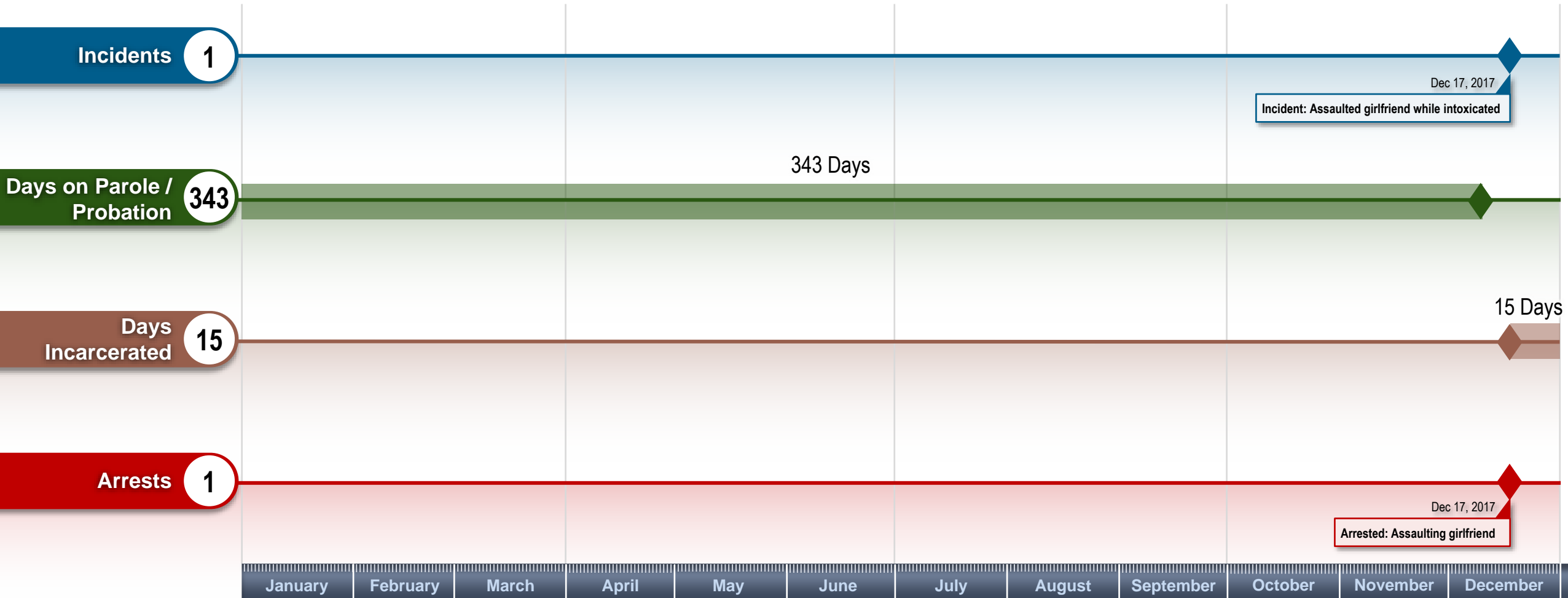

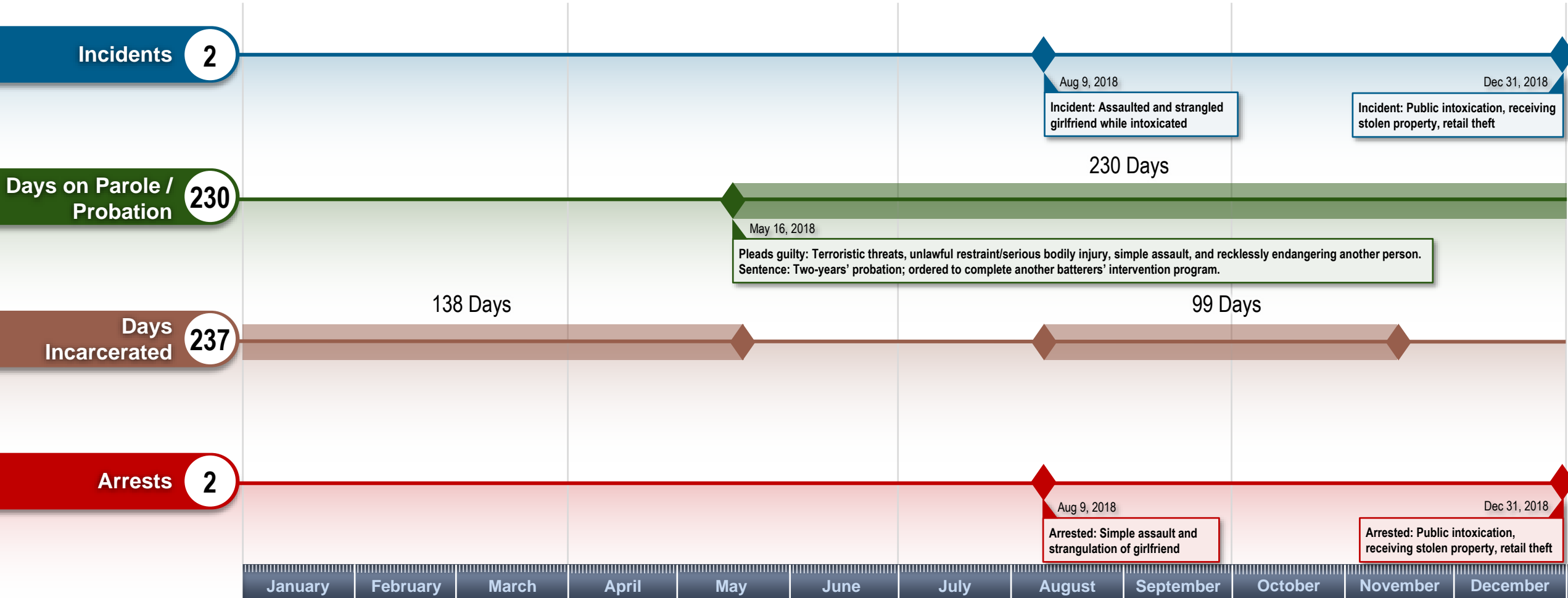

# Shakil Hairston Criminal History 2021

Incidents 2

Receives Level-of-Care Assessment (LOCA) at Gateway Rehab. Referred to Gateway Intensive Outpatient Services (2.1). Does not attend.

Jan 7, 2021

**Incident: Assaults, rapes, and sodomizes C.K. in his room**

Admitted to First Step Recovery housing. Referred to Mon Yough Community Services in McKeesport for LOCA.

Mar 10, 2021

Apr 26, 2021

Incident: DUI

Receives LOCA. Assessed by Mon Yough as needing intensive outpatient care (2.1). Discharged for non-attendance.

Mar 17, 2021

Fails breathalyzer at First Step Recovery. Case Mgr. Keenan Mikell notes continued struggles, criminal thinking.

Apr 7, 2021

247 Days

Discharged from First Step after wrecking his van while intoxicated.

Apr 16, 2021

**Receives LOCA at Renewal. Improperly assessed as being no risk to others so eligible for admission to Heuer House.**

**Pleads guilty to Statutory Sexual Assault, Involuntary Deviate Sexual Intercourse, and Promoting Prostitution of a Minor**

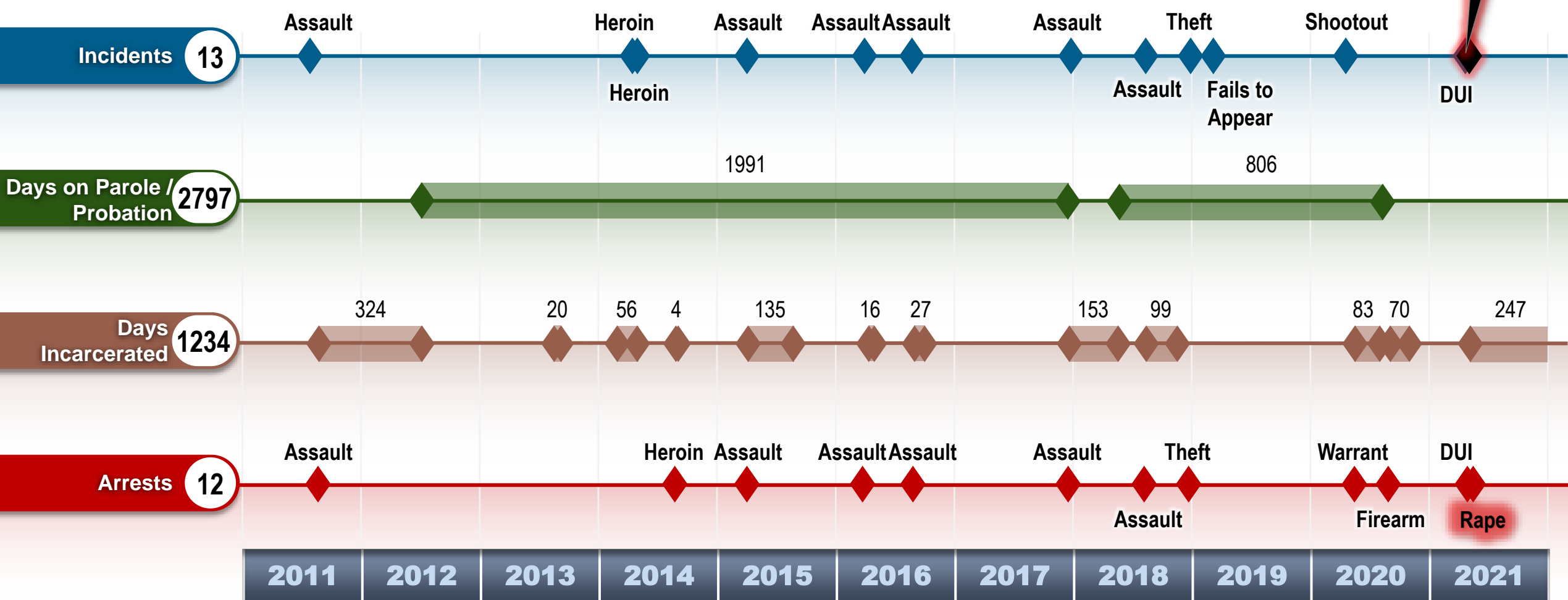
